### Chairman's Report

# From 1936 to 2021 - 85 years of campaigning for the countryside of Staffordshire

In the spring newsletter I wrote about some of the early history of CPRE Staffordshire. Here is another instalment. with some events of significance in our past. In 1937 Lord Harrowby (whose appeal had led to the founding of CPRE Staffordshire) informed the Branch's Council that Lord Anglesev had offered to give 130 acres of land at Beaudesert 'for the use of Boy Scouts and Girl Guides, provided a trust could be set up to control it.' This was done, and to this day the Chairman of CPRE Staffordshire is a Trustee of the Beaudesert Trust.

I have told you something in the last newsletter about the history of our charity up to the start of the Second World War in 1939. Meetings recommenced after a gap of six years in 1945 and the following year efforts were made to reactivate and reconstitute the committee. The minimum annual subscription was still 5 shillings, unchanged since 1936! In those days the County Branch was to pay annually 10% of its subscriptions and donations (except those donations earmarked for special purposes) to the Council for the Preservation of Rural England. These days it is the national CPRE which collects subscriptions and returns a

proportion to local groups like ours.

The 1948 Town and Country Planning Act offered hope for greater protection of the countryside and appeared to bring to fruition the aspirations of the pioneers like Clough Williams-Ellis and Professor Abercrombie who founded CPRE. Green Belts were set up around Staffordshire's two main conurbations, as well as the Peak District National Park and Cannock Chase Area of Outstanding Natural Beauty being established. Buildings could be 'listed' for architectural or historic interest and conservation areas designated. However the case for the countryside was a balancing act, as it is now.

I acknowledge with thanks the work of Bill Gee and Bob Bray in compiling the booklet about our first 70 years as a charity.

# Could you be our new chairman?

I have enjoyed being Chairman of CPRE Staffordshire for three years, a normal term of office for a chair within the organisation. However due to personal circumstances I shall not be seeking election again at the AGM in September for a further period of office. I am willing to continue on the committee as a trustee, with less active involvement.

### Staffordshire Way

Following on from the last newsletter, our initiative to breathe some new life into the Staffordshire Way has been moving on very well. By way of a brief reminder, the Staffordshire Way is a 92-mile route that has been in existence for over 50 years and captures some of the most iconic Staffordshire landscapes as winds its way between Mow Cop in the north and Kinver Edge at the south of the county.



We have been able to recruit a small but enthusiastic army of volunteers, who have been out and about surveying sections of the Staffordshire Way. What is clear is that most of the route is still quite good, some sections need some TLC, and in a few cases it has become almost impossible to follow the route.

Our volunteers have also been helping to build up a rich picture of information that hasn't previously been collated, such as, connections with public transport, places to park, useful businesses for walkers to use along the route, and sections that could be suitable for people with reduced mobility or buggies.

Possibly the most exciting development is that the County Council is getting behind the initiative and are hoping to promote the Staffordshire Way as a tourist

attraction in its own right and to use much of the information we are collecting to create a new online resource for anyone wanting to explore the route, and possibly even a new printed guidebook. The rights of way team are prioritising repairs to the way, and we even have a promise from the lead Councillor - Victoria Wilson to walk the entire length in early September.

There's still a way to go, but things are certainly looking promising. Watch this space!

# A new use for an old golf course



Local people are calling for a former golf course to be transformed into 'Silverdale Common' - for the benefit of both people and nature - rather than sold off for development.

Located in Silverdale and Keele in north Staffordshire, the former municipal golf course comprises 200 acres of pristine undeveloped woods, ponds and open grassland. It's hugely popular for local recreation and its central location gives it the potential to become a side of national interest.

However, as landowner and planning authority, NULBC is determined to sell off its land to the highest bidder for a market-led 'executive' housing estate of between 1,200-1,800 houses as part of its Keele University Growth Corridor. This is despite the fact that the council has a 5year land supply, local house prices are some of the lowest nationally, and there are many nearby brownfield sites that would benefit from regeneration instead.

Silverdale and Keele Parish councils' joint application to have the area accepted as an Asset of Community Value was rejected by NULBC with a key reason being that the site was already 'earmarked' for development. Given that the council has yet to begin consultation on its new Local Plan and the site is legally protected Green Belt land, it is alarming that its mind appears to be already made up.

Duncan Hindmarch has written an article for our website with more information about the golf course and what you can do to help protect it. If you have completed Newcastle-under-Lyme Borough Council's survey on open space, thank you - the results will be used to set an action plan for green infrastructure. ### Six Tests for Planning

CPRE and other charities including RSPB and the Wildlife Trusts have released six tests that new planning rules must pass to put people and nature first.

The six tests provide a scorecard that uses the government's own wording, from its Planning White Paper, to critically assess whether its vision for planning will become a reality in the Planning Bill.

The tests include measures across six key areas: local democracy, affordable homes, the climate emergency, nature, heritage and health.

# Community Planning Alliance

The CPA is a recently formed network of over 400 grassroots

campaign groups and activists tackling concerns in their local area. CPA's aims are to lobby on planning related issues on behalf of their members, and to support them with their environmental or planning campaigns. The key issues for their members include unsustainable housing, local plans, roads and incinerators. Their three areas of focus are environment and biodiversity, community engagement and evidence-based need/affordability.

### Hedgerows: 40by50

CPRE has launched its #40by50 campaign, calling on ministers to commit to extending the hedgerow network by 40% by 2050, as recommended by the independent Climate Change Committee.

This will mean adding over 4,000 miles of new and restored hedgerows per year - starting now.

# Government statement on Glover Review

Natural England has announced proposals for new protected areas across England following the Glover Review of protected landscapes. Under these proposals, four areas will be considered for greater protections, with potential to deliver over 40% of the additional 4.000km2 required to meet the Prime Minister's commitment to protect 30% of the UK by 2030 for nature. Two existing AONBs, in the Surrey Hills and Chilterns, will be extended, and Natural England will consider the possibility of two whole new AONBs in the Yorkshire Wolds and Cheshire.

The Defra-funded Farming in **Protected Landscapes** programme runs from 2021 to 2024. The first application window is open from 1 July 2021 to 31 January 2022. The programme supports activity on any land within Cannock Chase AONB. It can also support activity on land outside the AONB where projects can demonstrate benefit to Cannock Chase, or the AONB Partnership's objectives or partnership initiatives. Expressions of Interest are now invited:

### **Deposit Return Scheme**

CPRE is keeping up the pressure on the government to introduce a DRS, sending a

message to the Prime Minister on his birthday that it wants to see an all-in Deposit Return Scheme by 2023.

#### **Rural Affordable Housing**

The Rural Services Network has published a Parish Councillor's Guide to Affordable Housing. The guide sets out a wide range of information, useful to Parish Councillors considering their local areas. It answers question from everything such as 'what is affordable housing' and 'what planning routes are available' to more detailed guidance on Rural Exception Sites and how to deliver affordable rural housing.

#### **National Food Strategy**

A major new report for the government published in July has made a number of recommendations about what we eat and how we produce it. Its recommendations include guaranteeing the budget for agricultural payments until at least 2029 to help farmers transition to more sustainable land use and the creation of a Rural Land Use Framework.
